ORDER:

The following notification will be published in Tamil Nadu Government Gazette:-

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules:-

The rules hereby made shall be deemed to have come into force on the 11th August 1970.

RULES

The General Rules applicable to the holders of the permanent posts in the Tamil Nadu General Subordinate Service shall apply to the holders of the temporary post of Senior Artist in 'Tamil Arasu' unit in the public (Information and Public Relations) Department subject to the modifications specified in the following rules.

2. CONSTITUTION: The post shall constitute a separate class in the said service.

3. APPOINTMENT: - Appointment to the post shall be made by promotion from among the holders of the posts of Artist in 'Tamil Arasu' and in the office of the District Public Relations Officer now Office of the Special Assistants to Collectors (Information and Public Relations) or by transfer from any other class or by recruitment by transfer from any other service or by direct recruitment.

4. APPOINTING AUTHORITY: The appointing authority for the post shall be the Director of Information and Public Relations.

5. QUALIFICATIONS (a) AGE: No person shall be eligible for appointment to the post by direct recruitment if he has completed or will complete forty years of age on the 1st day of July of the year in which the selection for appointment is made.

(b) OTHER QUALIFICATIONS: No person shall be eligible for appointment to the post unless he possess the following qualifications, namely:

(i) Must held a Diploma in Commercial Art or painting awarded by the Tamil Nadu Board of Technical Education and Training, Madras or its equivalent; and

(ii) Must have practical experience in Commercial Art or Painting in the recognised or reputed firm for a total

Period of not less than three years.

Must be an Artist with practical experience in Commercial Art or Painting in a reputed firm for a period of not less than five years.

6. PROBATION: Every person appointed to the post by direct recruitment or by recruitment by transfer from any other service shall from the date on which he joins duty be on probation for a total period of two years on duty within a continuous period of three years.

7. PAY: There shall be paid to the holder of the post a monthly pay calculated in the scale of K. 225-15-375 provided that on and from the 2nd October 1976 the Monthly pay shall be calculated in the scale of pay of K. 400-15-475-20-575-25-650.
