The Commissioner of Technical Education and Head of State Project Facilitation Unit in his letter read above has stated that the University College of Engineering, Bharathidasan Institute of Technology, Tiruchirappalli has constituted the Board of Governors (BoG) as per the University Grants Commission guidelines given in the Project Implementation Plan (PIP) of Technical Education Quality Improvement Programme Phase-II except a State Government nominee.
