

The Principals of all Government, Government Aided, Self-Financing Engineering Colleges and Stand Alone Institutions are requested to furnish the details of surrender of seats to Single Window Counselling for admission to First Year MBA / MCA / MCA (Lateral Entry) degree courses for the academic year 2019-20 in prescribed format. The Formats are made available in DOTE Website (www.tndte.gov.in).

The details may be furnished on or before **03.08.2019** so as to enable this office to include the same under Single Window Counselling.

If MBA / MCA / MCA (Lateral Entry) degree courses are not proposed to be conducted for the year 2019-20, the Principals should inform this office well in advance. Failure to do so will result in allotment of candidates to such courses and the Institution will have to conduct the course for students under "Government Quota".

The Principals are informed that the details of seats surrendered will be considered final. No request for withdrawal / additional surrender will be entertained. Therefore the Principals are requested to finalize the seats to be surrendered and accordingly furnish details. If the surrender statement is not received, the GQ share of seats as per applicable intake will be included under Single Window Counselling.
